MACAA 2021 Annual Meeting Minutes

June 24, 2021 | Queenstown, MD

15 attendance in-person, 8 virtual

1. 12:40 pm: Pre-meeting discussion
 - a. Ginny Rosenkranz discussed the upcoming NACAA meeting (to be held virtually, in lieu of Philadelphia due to COVID). There is a suggestion to make a list of MACAA members that are presenting and the times of their presentations. Next year the NACAA meeting will be held in West Palm Beach, FL. We had monetary obligations to Philadelphia, some of which were forgiven but not all. Andy Kness will be our delegate for delegate session at 2021 NACAA meeting.
2. 12:52 pm: Call to order of MACAA business meeting
3. Welcome and Introduction of New Members and Guests
Paul Goeringer, MACAA President
 - a. Welcome to new MACAA members Charlie Sasscer and Haley Sater.
4. Recognize and congratulations to award winners:
 - a. Neith Little- Achievement award winner
 - b. Andrew Ristvey- Mid-Career award winner
 - c. Jenny Rhodes- Distinguished service award winner
 - d. We viewed Jenny Rhode's video highlighting her work (Distinguished service award).
5. Updates from David Handley, Northeast Rep
 - a. David reminded everyone of the upcoming AMPIC and to register if have not yet. 500 people registered as of last week. The NE regional meeting will be on Tuesday at 11:00AM. We are electing a new vice director for NE region (from DE or NJ).
 - b. David reminded everyone to apply for awards. One of the benefits of association membership is to get work recognized on national level through awards. Most deadlines are in Jan or March.
 - c. The NACAA website update has been a priority of the national board. The new version should be out in July 2021.
 - d. David reminded members of scholarships. Any active member is eligible if they are vested in scholarship fund. They are eligible for up to \$1000 scholarship for professional development (e.g., graduate work, professional meeting), or up to \$5000 for a tour group (e.g., go to neighboring state). An endowment may increase the amount of money available for scholarship or make more scholarships.
 - e. David reminded members to consider getting their work published in Journal of NACAA (peer-reviewed, quicker turnaround, less expense than other journals).
6. Minutes of the 2020 MACAA Summer Meeting
 - a. Paul Goeringer asked the group to approve minutes from last year. Ginny Rosenkranz made a motion to approve. Dave Myers seconded the motion, motion carried and minutes approved.

7. 1:20 pm: MACAA Financial Report
 - a. Emily Zobel is the new MACAA treasurer. She opened a PNC checking account. \$10,633 in savings; \$2536 checking. Ben Beale is co-signer. Ginny Rosenkranz made a motion to approve financial report. Neith Little seconded the motion, motion carried.
8. 1:24 pm: Old Business
 - a. Paul Goeringer asked for old business; nothing brought up.
9. 1:25 pm: New Business
 - a. Paul Goeringer started discussion of new business.
 - b. 2022 Meeting location:
 - i. There was a discussion of where and when to hold MACAA meeting in summer 2022. Suggestion given were week of June 13th, week of June 20th, or week of June 27th. Tradition had meeting 1 week before 4th July at Ocean City, MD. Ginny Rosenkranz will call for options at Ocean City and Cambridge. Someone else will be responsible to investigate options off the Eastern Shore.
 - c. Adding dues to Annual Summer Meeting:
 - i. There is a suggestion to collect annual dues with summer MACAA meeting registration. The majority consensus was to try to do that.
 - d. Filling Open Committees and Committee Assignments:
 - i. There was a discussion of filling open committees and committee assignments. Haley Sater will take over professional excellence from Emily Zobel. Alan Leslie took over communications when Nate Richards resigned. For the Policy and Nomination, rotates to the preceding presidents (for past 5 years). Dave Myers made a motion to approve these assignments. Nevin Dawson seconded the motion, motion carried.
 - e. Other new business items:
 - i. Dave Myers brought up the need for administrative support for faculty. Shannon Dill brought up questions about office coverage and support to faculty members. We do not have a state level administration support team, and it is important to know what specialties/resources are located among the county administrators. For example, who specializes in communications and website development? Shannon Dill and Neith Little brought up question of do we have someone at program level in communications? There was a discussion of the problem with website searches bringing up appropriate results.
 - ii. Dave Myers brought up that we have lost some critical positions in Ginger Myers and Kate Everts. Darren Jarboe is looking for group of people to talk to John Erwin (Plant Science Dept Chair) about Kate Everts vacant position. The purpose of the MACAA Foundation Fund Committee is to consider and recommend expenditures to the Foundation Fund Governing Board. The Foundation supports the professional improvement of its members and the improvement of the MACAA organization. In addition, the Foundation helps to create awareness by individuals and organization of the purpose of the NACAA Foundation Fund.

The Foundation is an account under the MACAA Federal Tax Identification number and is exempt from Federal income tax under section 501 (c), (6) of the Internal Revenue Code. Contributions to the account are not tax deductible.

Activity during the past year is shown on the following Balance Sheet and Income and Expense statements. No reimbursements were issued in '21 as the annual meeting was virtual.

Please note that the present balance in the Edward Jones account reflects a reserve of interest income from past years as well as restricted corpus assets (equal to \$26,772.51).

As of December 31, 2021, the Foundation had a PNC checking account balance of \$9084.43. The Edward Jones Investment account had a balance of \$63,426.05 (increased 8.85%). The total net value is \$72,510.48 which is up **\$5,158.34**.

AGRONOMY & PEST MANAGEMENT

The Maryland Agronomy News newsletter was continued in 2021-2022 with volumes 12 and 13. A total of 8 issues are published annually and distributed across the state via e-mail and hard copy mailings. HORTICULTURE AND TURFGRASS

2015-2021 Maryland Department of Agriculture and University of Maryland collaborated to create teaching points and power point programs for Commercial Pesticide Applicators and Professional Fertilizer Applicators for Re-Certification. There are now over 1,700 certified Professional Fertilizer Applicators (PFA) in Maryland who receive re-certification credits each year, often in conjunction with Commercial Pesticide Recertification through the University of Maryland Extension. There are over 1200 licensed pest control businesses, over 250 licensed public agencies and over 3,000 certified applicators in the state of Maryland, and they need to be recertified each year. There are 2 commercial pesticide recertification programs on the Eastern Shore and 2-4 programs on the western shore per year to provide opportunities for the PFA to earn recertification each year.

The Maryland Nursery, Landscape and Greenhouse Association and University of Maryland Extension continue to collaborate to bring more horticultural conferences available to the Maryland Green Industry. The very successful educational conference created by Maryland Extension Educators and Specialists include Chesapeake Green, A Horticulture Symposium, The Cut Flower Short Course and Summer Tour, the Greenhouse Short Course, the Alternative Crops Course, Storm Water Management Conference, and the MNLGA Field Day. There are 2 commercial pesticide recertification conferences on the Eastern shore, the Eastern Shore Pest Management Conference and the Eastern Shore Procrastinators Conference. The western shore holds many pesticide recertification's as well as a Biological Control Conference, Turf conferences and IPM Pest conferences.
